Positions requiring any endorsements or other restrictions must be met and demonstrated by applicants. Applicant must possess a Valid CDL license that permits the operation of standard and automatic vehicles. Applicants must be Medically Self-Certified as Non-Excepted, Interstate. Applicant's CDL must be valid and current with the State Licensing Agency, to include the most current medical certification, within 15 days of receipt.

Medical certification must be obtained through the Norfolk Southern approved vendor CHS. Others will not be recognized.

You must have a clear photocopy of your CDL & Medical Card on file with our office to be awarded a job requiring a CDL. Failure to provide copy of current CDL & Medical Card could result in the position being awarded to a junior employee.

For Foreman, Assistant Foreman, Welders and Flagging Foreman only – the successful applicant must be qualified in 49 CFR § 213.7 (a) (b) and (c) prior to being awarded the position.

§243.1 Purpose and scope.

(a) The purpose of this part is to ensure that any person employed by a railroad or a contractor of a railroad as a safety-related railroad employee is trained and qualified to comply with any relevant Federal railroad safety laws, regulations, and orders, as well as any relevant railroad rules and procedures promulgated to implement those Federal railroad safety laws, regulations, and orders.
